1. The Customer authorizes Easyrefills.com.au to make enquiries regarding the credit worthiness of the Customer and/or the Directors of the Customer as required by Easyrefills.com.au, including seeking information from credit reporting agencies.
2. Trading terms are strictly 30 days from date of invoice.
3. If an account is overdue, Easyrefills.com.au may
 - a. Withdraw credit facilities without notice,
 - b. Charge interest at the current bank rate on the outstanding balance,
 - c. Charge the Customer all reasonable costs incurred in the debt recovery process.
4. It is expressly agreed that the title in any goods supplied by Easyrefills.com.au shall not pass to the Customer until the full purchase price and any amounts outstanding to Easyrefills.com.au in respect of goods supplied by it to the Customer have been paid in full and credited into the Easyrefills.com.au bank account. While title remains with Easyrefills.com.au, the Customer shall hold them as Bailee for Easyrefills.com.au. If the amounts due and payable remain unpaid, Easyrefills.com.au shall be entitled to enter the premises of the Customer and repossess such goods belonging to it.
5. It is Easyrefills.com.au intention to deliver all goods on the day of order, but no liability can or will be accepted in case of late delivery. Physical delivery of goods to a carrier or the Customer's agent shall constitute delivery to the Customer. It is the Customer's responsibility to inspect the goods promptly upon receipt and notify Easyrefills.com.au in writing of any discrepancies within seven working days thereafter.
6. Application for return of goods must be made within fourteen days from receipt of the goods, and must be made in writing prior to returning the goods. No goods will be accepted for refund unless they are returned to the factory in a pristine and merchantable condition.
7. Unless stated otherwise in writing, all products are warranted for a period of 1 year from the date of purchase by the end user. All Customers should be aware that an inkjet cartridge should be refilled while working perfectly, and that the Customer should not place a cartridge in a printer if the cartridge is leaking.
8. These terms shall be governed by and interpreted according to the laws of Queensland and Easyrefills.com.au and the Customer consents and submits to the jurisdiction of the courts of Queensland.
